## School Facility Conditions and Planned Improvements

The facilities consist of 3 classrooms -- two main buildings, a portable, and a bus garage. There is also a small office and a meeting room area which can be curtained off from the large classroom. A part time maintenance person and a custodian maintain these facilities and grounds. Students play either on a grassy field or on asphalted areas. Playground equipment consists of swings, slide, and climbing structure. A garden area is maintained as a classroom project and parents. In 1999, the district completed a Modernization Project.

The oldest classroom, built in 1951, was remodeled and the kitchen expanded. In 1984, the district built the second classroom, meeting room and office area and remodeled the bathrooms. The portable was leased from the state in 1994 and purchased in 2002. It has been used primarily as a classroom, a library, or special projects area. In 2009-10 the district repaved the last section of old asphalt on the playground. New bathroom stalls and lighting have been installed in both girls' and boys' restrooms. All main school buildings, the portable, and the observatory were repainted during the summer of 2023. A safety fence was installed to separate the play area from the parking lot in August 2023.

## Professional Development

Professional Development opportunities are offered to staff on an individual basis to best fit the needs of each staff member. Due to the nature of the small school, each staff member is solely responsible for a duty set at the school -- one teacher for TK-2, one teacher for 3-5, and one teacher for 6-8, one staff member responsible for transportation, one staff member responsible for water safety, etc. Each staff member is permitted time away from school to complete professional development tasks.
